

Freddie Mac Prices \$549 Million Multifamily KG-Deal, K-G03

MCLEAN, Va., Aug. 06, 2020 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are multifamily mortgage-backed securities. The company expects to issue approximately \$549 million in K Certificates (K-G03 Certificates), which are expected to settle on or about August 13, 2020.

KG-Deals are the environmental and social impact series of Freddie Mac's K-Deal program. They exclusively securitize workforce housing loans made through the company's Green Advantage® program.
