

Freddie Mac Prices \$1 Billion Multifamily K-Deal, K-731

MCLEAN, Va., April 09, 2018 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB:FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 7-year terms. The company expects to issue approximately \$1 billion in K-731 Certificates, which are expected to settle on or about April 13, 2018.
