



Freddie Mac Prices \$1.1 Billion Multifamily K-Deal, K-075

MCLEAN, Va., April 20, 2018 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB:FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)), which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.1 billion in K Certificates (K-075 Certificates), which are expected to settle on or about April 27, 2018.
