



Freddie Mac Prices \$1.1 Billion Multifamily K-Deal, K-080

MCLEAN, Va., Sept. 14, 2018 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)), which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.1 billion in K Certificates (K-080 Certificates), which are expected to settle on or about September 26, 2018.
