

## Freddie Mac Prices \$862 Million Multifamily K-Deal, K-733

MCLEAN, Va., Nov. 02, 2018 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 7-year terms. The company expects to issue approximately \$862 million in K-733 Certificates, which are expected to settle on or about November 9, 2018.
