

## Freddie Mac Prices \$1.3 Billion Multifamily K-Deal, K-734

MCLEAN, Va., April 12, 2019 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 7-year terms. The company expects to issue approximately \$1.3 billion in K-734 Certificates, which are expected to settle on or about April 18, 2019.
