

Freddie Mac Announces Pricing of \$561 Million Multifamily Small Balance Loan Securitization

MCLEAN, Va., May 16, 2019 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB: FMCC) announces the pricing of the SB62 offering, a multifamily mortgage-backed securitization backed by small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to guarantee approximately \$561 million in Multifamily SB Certificates (SB62 Certificates), which are anticipated to settle on or about May 24, 2019. Freddie Mac Small Balance Loans generally range from \$1 million to \$6 million and are generally backed by properties with five or more units. This is the fifth SB Certificate transaction in 2019.

Freddie Mac is guaranteeing five senior principal and interest classes and one interest only class of securities issued by the FRESB 2019-SB62 Mortgage Trust. Freddie Mac is also acting as mortgage loan seller and master servicer to the trust. In addition to the six classes of securities guaranteed by Freddie Mac, the trust will issue certificates consisting of Class B and Class R Certificates, which will not be guaranteed by Freddie Mac and will be sold to private investors.

The Optigo SM Small Balance Loan (SBL) origination initiative was first announced in October 2014, and expands the company's continuing effort to better serve less populated markets and provide additional liquidity to smaller apartment properties. Freddie Mac has a specialty network of Optigo Seller/Servicers and Optigo SBL lenders with extensive experience in this market who source loans across the country.
