



Freddie Mac Prices \$1.2 Billion Multifamily K-Deal, K-097

MCLEAN, Va., Sept. 12, 2019 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 10-year terms. The company expects to issue approximately \$1.2 billion in K Certificates (K-097 Certificates), which are expected to settle on or about September 24, 2019.
