



Freddie Mac Announces Pricing of \$387 Million Multifamily Small Balance Loan Securitization

MCLEAN, Va., July 21, 2020 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB: FMCC) announces the pricing of the SB76 offering, a multifamily mortgage-backed securitization backed by small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to issue approximately \$387 million in SB Certificates (SB76 Certificates), which are expected to settle on or about July 24, 2020. Freddie Mac Small Balance Loans generally range from \$1 million to \$7.5 million and are generally backed by properties with five or more units. This is the seventh SB Certificate transaction in 2020.
