

# Freddie Mac Prices \$1.2 Billion Multifamily K-Deal, K-114

MCLEAN, Va., Aug. 14, 2020 (GLOBE NEWSWIRE) -- <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 10-year terms. The company expects to issue approximately \$1.2 billion in K Certificates (K-114 Certificates), which are expected to settle on or about August 20, 2020.
