



Freddie Mac Announces Pricing of \$382 Million Multifamily Small Balance Loan Securitization

MCLEAN, Va., July 16, 2021 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB: FMCC) announces the pricing of the SB88 offering, a multifamily mortgage-backed securitization backed by small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to issue approximately \$382 million in SB Certificates (SB88 Certificates), which are expected to settle on or about July 23, 2021. Freddie Mac Small Balance Loans generally range from \$1 million to \$7.5 million and are generally backed by properties with five or more units. This is the seventh SB Certificate transaction in 2021.
