



## Freddie Mac Announces Pricing of \$349 Million Multifamily Small Balance Loan Securitization

MCLEAN, Va., Nov. 10, 2021 (GLOBE NEWSWIRE) -- [Freddie Mac](#) (OTCQB: FMCC) announces the pricing of the SB92 offering, a multifamily mortgage-backed securitization backed by small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to issue approximately \$349 million in SB Certificates (SB92 Certificates), which are expected to settle on or about November 19, 2021. Freddie Mac Small Balance Loans generally range from \$1 million to \$7.5 million and are generally backed by properties with five or more units. This is the eleventh SB Certificate transaction in 2021.
