

Freddie Mac Forgoes Issuing a Reference Notes Security on its July 20, 2017 Announcement Date

MCLEAN, VA--(Marketwired - Jul 20, 2017) - Freddie Mac (OTCQB: FMCC) announced today that it will forgo issuing a Reference Notes[®] security on its July 20, 2017 announcement date. The company's <u>2017 Reference Notes calendar pdf</u> designates dates that it may use to announce the issuance of Reference Notes securities.
