



## Freddie Mac Prices \$212 Million Multifamily K-Deal, K-J11

February 1, 2017

MCLEAN, VA--(Marketwired - Jan 31, 2017) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)) that are backed by underlying collateral consisting of supplemental multifamily mortgages. The company expects to issue approximately \$212 million in K Certificates (K-J11 Certificates), which are expected to settle on or about February 15, 2017.
