

Freddie Mac Prices \$1 Billion Multifamily K-Deal, K-061

MCLEAN, VA--(Marketwired - Jan 23, 2017) - <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K</u> <u>Certificates</u>), which are multifamily mortgage-backed securities. The company expects to issue approximately \$1 billion in K Certificates (K-061 Certificates), which are expected to settle on or about January 30, 2017.
