

Freddie Mac Prices \$1 Billion Multifamily K-Deal, K-724

MCLEAN, VA--(Marketwired - Jan 20, 2017) - Freddie Mac (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (K Certificates), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 7-year terms. The company expects to issue more than \$1 billion in K-724 Certificates, which are expected to settle on or about January 25, 2017.
