



Freddie Mac Prices \$1.2 Billion Multifamily K-Deal, K-729

December 19, 2017

MCLEAN, VA--(Marketwired - Dec 19, 2017) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with predominantly 7-year terms. The company expects to issue approximately \$1.2 billion in K-729 Certificates, which are expected to settle on or about December 22, 2017.
