

## Freddie Mac Prices \$1.1 Billion Multifamily K-Deal, K-070

December 4, 2017

MCLEAN, VA--(Marketwired - Dec 4, 2017) - <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K Certificates</u>), which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.1 billion in K Certificates (K-070 Certificates), which are expected to settle on or about December 12, 2017.

The K-70 Trust will also issue certificates consisting of the Class X2-A, X2-B, B, C, D and R Certificates, which will not be guaranteed by Freddie Mac and will not back any class of K-070 Certificates.
