



## Freddie Mac Prices \$43.1 Million in Structured Credit Risk Debt Notes

MCLEAN, VA--(Marketwired - Dec 29, 2016) - [Freddie Mac](#) (OTCQB: FMCC) today announced it recently priced its second offering of a Multifamily Structured Credit Risk (SCR) Debt Note, which gives private investors a portion of the credit risk on certain multifamily mortgage loans backing targeted affordable rental housing tax-exempt bonds guaranteed by Freddie Mac. The approximately \$43.1 million in [SCR Notes](#) (pronounced SCORE Notes) are expected to settle on or around December 29, 2016.

Introduced in May 2016, SCR Notes are unsecured and unguaranteed corporate bonds that build on the company's successful multifamily securities offerings and single-family Structured Agency Credit Risk® debt notes, and reduce taxpayers' exposure to mortgage default risk. With SCR Notes, the first-loss credit risk of a specified pool of mortgages is transferred to private capital markets credit investors. Freddie Mac retains the senior loss credit risk.

### SCR Notes Series 2016-MDN2 Pricing

The \$43.1 million SCR Notes Series 2016-MDN2, Class B, is linked to the credit and principal payment risk of a reference pool of multifamily mortgage loans backing state and local housing finance agency tax-exempt bonds for which Freddie Mac provides credit enhancement. The SCR Notes are not backed or secured by the reference pool itself. Wells Fargo is the sole structuring agent, lead manager and sole bookrunner. Systema Capital Management is the sole investor for the issued notes.

The amount of periodic principal and ultimate principal paid by Freddie Mac is determined by the performance of the reference pool consisting of approximately 68 multifamily mortgage loans originated between 1999 and 2016 with an approximate unpaid principal balance of \$863 million. The mortgage loans were primarily funded by the issuance of targeted affordable rental housing tax-exempt bonds guaranteed by Freddie Mac. The loans adhere to Freddie Mac's underwriting, internal fraud prevention and quality control standards.
