



Freddie Mac Prices \$244 Million Multifamily K-Deal, K-J10

December 7, 2016

MCLEAN, VA--(Marketwired - Dec 7, 2016) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)) that are backed by underlying collateral consisting of supplemental multifamily mortgages. The company expects to issue approximately \$244 million in K Certificates (K-J10 Certificates), which are expected to settle on or about December 21, 2016.
