



Freddie Mac Prices \$1 Billion Multifamily K-Deal Backed by 19 California Properties Controlled by The Irvine Company

MCLEAN, VA--(Marketwired - May 5, 2016) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)), which are multifamily mortgage-backed securities. The company expects to issue approximately \$1 billion in K Certificates (K-IR1 Certificates), which are backed by 19 properties located in California and indirectly controlled by The Irvine Company LLC. The K-IR1 Certificates are expected to settle on or about May 11, 2016.

The K-IR1 Certificates will not be rated, and include two senior principal and interest classes and one interest-only class. The K-IR1 Certificates are backed by corresponding classes issued by the FREMF 2016-KIR1 Mortgage Trust (K-IR1 Trust) and guaranteed by Freddie Mac. The K-IR1 Trust will also issue certificates consisting of the Class B and R Certificates, which will be subordinate to the classes backing the K-IR1 Certificates. The K-IR1 Trust Class B and R Certificates will not be guaranteed by Freddie Mac.

Freddie Mac Multifamily is a leading issuer of agency-guaranteed structured multifamily securities. K-Deals are part of the company's business strategy to transfer a portion of the risk of losses away from taxpayers and to private investors who purchase the unguaranteed subordinate bonds. K Certificates typically feature a wide range of investor options with stable cash flows and structured credit enhancement.
