

Freddie Mac Prices \$528 Million Multifamily K-Deal, K-504

January 21, 2016

MCLEAN, VA--(Marketwired - Jan 21, 2016) - <u>Freddie Mac</u> (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (<u>K</u> <u>Certificates</u>), which are backed by underlying collateral consisting of fixed-rate multifamily mortgages with 5-year terms. The company expects to issue more than \$528 million in K-504 Certificates, which are expected to settle on or about January 29, 2016.
