

Tenth Freddie Mac Guaranteed Multifamily Small Balance Loan Securitization Prices

MCLEAN, VA--(Marketwired - Dec 14, 2015) - Freddie Mac (OTCQB: FMCC) announces the pricing of the SB10 offering, a multifamily mortgage-backed securitization backed by small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to guarantee approximately \$133 million in SB10 Certificates, which are anticipated to settle on or about December 30, 2015. This is the tenth small balance loan securitization the company has brought to the market since August and its last one for this year.

Freddie Mac is guaranteeing three senior principal and interest classes and an interest only class of securities issued by the FRESB 2015-SB10 Mortgage Trust and is also acting as mortgage loan seller and master servicer to the trust. In addition to the four classes of securities guaranteed by Freddie Mac, the trust will issue certificates consisting of the Class B, X2 and R Certificates, which will not be guaranteed by Freddie Mac and will be sold to private investors.

The <u>Small Balance Loan</u> (SBL) origination initiative was first announced in October 2014, and expands the company's continuing effort to better serve less populated markets and provide additional liquidity to smaller apartment properties. Loans in the program generally range from \$1 million to \$5 million and have five or more units. Freddie Mac has a specialty network of Seller/Servicers and SBL lenders with extensive experience in this market who source loans across the country. Freddie Mac purchases and aggregates loans by seller and will then securitize each seller's deals when pool sizes are generally more than \$100 million.
