



Freddie Mac Prices \$976 Million Multifamily K-Deal, K-051

MCLEAN, VA--(Marketwired - Dec 14, 2015) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)) which are multifamily mortgage-backed securities. The company expects to issue approximately \$976 million in K Certificates (K-051 Certificates), which are expected to settle on or about December 18, 2015.
