

Freddie Mac Announces the Issuance of a New Two-Year Reference Notes® Security

MCLEAN, VA--(Marketwired - Dec 9, 2015) - Freddie Mac (OTCQB: FMCC) announced today that it plans to issue a new two-year USD Reference Notes[®] security, CUSIP number 3137EADX4, due on December 15, 2017. The issue will be priced on Thursday, December 10, 2015, and will settle on Friday, December 11, 2015, at benchmark size.

The new two-year Reference Notes security will be offered via a syndicate of dealers headed by Nomura Securities, International, Inc., TD Securities Inc. and Wells Fargo Securities, LLC. An application was made to list the issue on the Euro MTF market of the Luxembourg Stock Exchange.
