

Freddie Mac Prices \$1.25 Billion Multifamily K-Deal, K-050

MCLEAN, VA--(Marketwired - Nov 24, 2015) - Freddie Mac (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates (KCertificates) which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.25 billion in K Certificates (K-050 Certificates), which are expected to settle on or about November 24, 2015.
