



## Freddie Mac Prices \$1.3 Billion Multifamily K-Deal, K-049

MCLEAN, VA--(Marketwired - Oct 23, 2015) - [Freddie Mac](#) (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ([K Certificates](#)) which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.3 billion in K Certificates (K-049 Certificates), which are expected to settle on or about October 29, 2015. This is the company's twenty first K Certificates offering this year.
