

Third Freddie Mac Guaranteed Multifamily Small Balance Loan Securitization Prices

MCLEAN, VA--(Marketwired - Sep 15, 2015) - Freddie Mac (OTCQB: FMCC) today priced its third series of SB Certificates, which are backed by multifamily small balance loans underwritten by Freddie Mac and issued by a third-party trust. The company expects to guarantee approximately \$193 million in SB Certificates (SB3 Certificates) which are expected to settle on or about September 23, 2015.

Freddie Mac is guaranteeing the senior securities issued by the FRESB 2015-SB3 Mortgage Trust, and is acting as mortgage loan seller and master servicer. The third-party trust will also issue certificates consisting of the Class B, X2 and R Certificates, which will not be guaranteed by Freddie Mac and will be sold to private investors.

The <u>Small Balance Loan</u> (SBL) origination initiative was first announced in October 2014, and expands the company's continuing effort to better serve less populated markets and provide additional liquidity to smaller apartment properties. Loans in the program generally range from \$1 million to \$5 million and have five or more units. Freddie Mac has a specialty network of Seller/Servicers and SBL lenders with extensive experience in this market who source loans across the country. Freddie Mac purchases and aggregates loans by seller and will then securitize each seller's deals when pool sizes are approximately \$100-\$125 million.
