

## Freddie Mac Prices Sixth Multifamily K-Deal of the Year, K-044

April 14, 2015

MCLEAN, VA--(Marketwired - Apr 13, 2015) - Freddie Mac (OTCQB: FMCC) recently priced a new offering of Structured Pass-Through Certificates ("K Certificates") which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.3 billion in K Certificates ("K-044 Certificates"), which are expected to settle on or about April 21, 2015. This is the company's sixth K Certificates offering this year.
