



## Freddie Mac Announces Sixth Multifamily K-Deal of the Year, K-044

MCLEAN, VA--(Marketwired - Apr 7, 2015) - [Freddie Mac](#) (OTCQB: FMCC) today announced a new offering of Structured Pass-Through Certificates ("K Certificates") which are multifamily mortgage-backed securities. The company expects to issue approximately \$1.3 billion in K Certificates ("K-044 Certificates"), which are expected to price the week of April 6, 2015, and settle on or about April 21, 2015. This is the company's sixth K Certificates offering this year.

The K-044 Certificates are backed by 76 recently-originated multifamily mortgages and are guaranteed by Freddie Mac. The K-044 Certificates will be offered to the market by a syndicate of dealers led by Credit Suisse Securities (USA) LLC and Morgan Stanley & Co. LLC as co-lead managers and joint bookrunners. Barclays Capital Inc., J.P. Morgan Securities LLC, Citigroup Global Markets Inc. and Mischler Financial Group, Inc. will serve as co-managers.

The K-044 Certificates include two senior principal and interest classes, one senior interest only class and one junior interest only class. The three senior classes are expected to receive ratings of "AAAsf" from Fitch Ratings, Inc. and "AAA(sf)" from Kroll Bond Rating Agency, Inc., subject to ongoing monitoring.

The K-044 Certificates are backed by corresponding classes issued by the FREMF 2015-K44 Mortgage Trust ("K-44 Trust") and guaranteed by Freddie Mac. The K-44 Trust will also issue certificates consisting of the Class B, C, D, X2-A, X2-B and R Certificates, which will not be guaranteed by Freddie Mac and will not back any class of K-044 Certificates.

Freddie Mac Multifamily is a leading issuer of agency-guaranteed structured multifamily securities. K-Deals are part of the company's business strategy to transfer a portion of the risk of losses away from taxpayers and to private investors who purchase the unguaranteed subordinate bonds. K Certificates typically feature a wide range of investor options with stable cash flows and structured credit enhancement.
