

Freddie Mac Announces \$500 Million Reopening of 1.00% Reference Notes® Security Due July 28, 2017

MCLEAN, VA--(Marketwired - Feb 11, 2015) - Freddie Mac (OTCQB: FMCC) announced today that it plans to launch a \$500 million reopening of its 1.00% USD Reference Notes[®] security that matures on July 28, 2017. The issue will price today, Wednesday, February 11, 2015, and will settle on Thursday, February 12, 2015.

The \$500 million reopening of the 1.00% Reference Notes security will be conducted via an Internet-based auction. The issue, CUSIP 3137EADJ5, is listed on the Euro MTF market of the Luxembourg Stock Exchange. After the reopening, the outstanding size of the 1.00% Reference Notes security will be \$4.5 billion.
